# Edmonton Federation of Community Leagues City of Edmonton Recreation Facilities Access Options March 17, 2016 Meeting Notes

Thank you to all of the volunteers who attended the March 17th, 2016 meeting. Your interest and participation is appreciated.

#### 1. 2016 Community League Swim Survey results

A survey was conducted in February of 2016 to obtain feedback on the weekly Community Swim program. The following highlights from the survey were shared:

- 157 Community Leagues invited to complete the survey
- 43 survey completed
- 38 Community Leagues participated
- 49% belong to an Area Council
- Awareness of swim option high in comparison to the Community League Wellness Program, Bulk Admission Passes and Community League Ice Rentals.
- 4 out of 5 leagues participate in a swim program.
- Top 3 barriers to weekly swim are lack of interest, lack of awareness, value for money.
- Overall satisfaction with the weekly swim program is 87%. Value for money (avg. to very good) is 74%. Satisfaction with available day and time of swim is 68%.
- Reaction to additional option: 60% prefer the "program addition" over the current program. The addition was described as: "Pay a flat rate and get access to designated swim times at a few locations, not exclusive to your league (swims would be shared with a larger variety of leagues)"

#### 2. Discussion Highlights

- Leagues are interested in the opportunity for increased flexibility in times and locations and would like the City to further consider implementation of the new, additional option described in the survey. A clear explanation of how this option is structured is important.
- Positive feedback regarding the booking process and interactions with City bookings staff was expressed.
- Current invoices can be challenging to understand; additional formats or detail on invoices would be helpful.
- Leagues would like the City to consider alternative times for Community League Swims, particularly either later or earlier than the traditional supper hour e.g. 5-7pm.
- For the Leagues that identified Bulk Admission pass purchases as the most economical option for them, there was discussion around the best way to pool their individual purchases to benefit from the higher discounts offered for larger purchases. The EFCL may be interested in facilitating the purchase of a large volume of passes to receive the greatest discount and will discuss this possibility further with interested leagues. Challenges with the logistics of distributing passes once purchased were also mentioned; the option of direct billing based on 'scans' following use instead of paper passes was of interest to some leagues but not all due to the inability to anticipate final cost.
- Leagues also noted that the corporate discount at 20% is of greater value than the Community League discount of 10%; leagues questioned the reasoning for this and asked for the difference in discount to be considered.





#### 3. Current Community League Opportunities to Access City of Edmonton Recreation Centres

 An overview of current opportunities for Community Leagues to access City of Edmonton Recreation Centres was reviewed. These options are attached to this document.

#### 4. Outcomes and Next Steps

- Based on feedback received, the City of Edmonton will further develop the details of the new, additional flat rate program option and implement as a pilot program. The details of the pilot and start date will be provided to leagues once confirmed. Please base your plans to participate on the existing 2016/17 community league recreational access options outlined below.
- Details of the 2016 Outdoor Pool Swim access option are outlined in the community league recreational access options below. With the introduction the new Outdoor Pool Season Pass, the City of Edmonton will assess uptake and attendance throughout 2016. Additional community league access weekday day-time hours may be considered for the 2017 outdoor pool season.
- The City of Edmonton will provide leagues with participation information mid-way and at the end of each season (in the past has been provided upon request and at the yearly meeting). Please contact <a href="mailto:aquaticbookings@edmonton.ca">aquaticbookings@edmonton.ca</a> for any questions about your invoice or for additional information City staff will continue to work individually with leagues requiring additional clarification about their invoices.
- In response to feedback regarding the hours available, the City will continue to select times that balance the demand for pool and facility access with the desired of community league members. This will result in avoiding peak facility access times. In some cases, where there is high demand for public access
- The change to the Community League Wellness Program discount (drop from 20% to 10%) was
  introduced in 2012. Each company participating in the Corporate Wellness Program enters into
  an agreement that requires minimum membership purchase commitments. There is no
  administration or minimum purchase required by Community Leagues in order for Community
  League members to enjoy the discount. The discount structure offered via both programs is being
  reviewed.





# **Community League Recreational Access Options**

# **Option #1: Exclusive Pool Use**

The original program: exclusive use by Community Leagues, where the cost of an exclusive weekly pool rental is shared among participating leagues. The cost per league depends on the pool selected (rental rates vary based on pool size), length of the swim time selected, number of lifeguards required for expected attendance and the number of participating leagues sharing the cost.

#### **Option #3 Community League Wellness Program**

This program was developed in cooperation with the EFCL and provides current members of any Edmonton Community League with a 10% discount off annual, continuous monthly and multi-admission memberships. Community League Members must present a valid Community League membership card in order to obtain the discount. This program is easy to administer requiring no effort or resources on behalf of the leagues. As this program is provided at no charge to leagues, this option is particularly useful for leagues with extremely limited budgets.

#### **Option #4 Bulk Admission Purchases**

A Community League may choose to purchase bulk single admissions to our facilities by contacting our Corporate Sales Representative at 780-944-7744. The following bulk discount scale applies:

The challenge with this option is that for many leagues it is difficult to distribute the passes to their members. The discounted admissions may, however, be something you decide to provide as an incentive to new or renewing community league members.

#### **Additional Opportunities**

#### **Outdoor Pool Swim**

Includes access to all outdoor pools during set times and days varying among the four City of Edmonton outdoor pools. A flat fee allows Community Leagues to access pools for the duration of the summer. The 2016 outdoor pool swim fee is \$565.00.

#### **NEW for 2016- Outdoor Pool Season Pass**

This pass will provide access to outdoor pool's for the entire season at discounted rates (no other discounts may apply to these passes). This opportunity is available to all citizens and may be an alternative to those leagues not interested in the Community League outdoor swim program.

Child: \$49 Adult: \$75

Youth/Senior: \$59 Family: \$199





#### **Community League Ice Rentals**

Community Leagues are eligible to rent ice during the Winter Ice Season of Sept – March, for approved Community League programs. (These have to be unique from any other organized program being offered within the Community).

Applications are accepted in February for the following Winter Ice Season.

The cost per league depends on whether the program is for Minors or Adults, length of time, and time of day selected. Various days, times and locations are available. • Is required to follow safe practices with information provided by ENW. (As authorized by the Freedom of Information and Protection of Privacy Act) and shall not be used for any other purposes.

#### Dear Community League President:

The City of Edmonton is pleased to announce the return of our free, drop-in recreation programs for the summer of 2016. The City of Edmonton will be hosting programs in 228 neighbourhoods. These programs are made possible through the generous support of many community leagues and the City of Edmonton's commitment to providing base funding.

#### **Program Selection Information**

In 2016, there will be 180 Green Shack locations, including 23 extended hours programs. The number of extended-hour sites increased from 20 in 2015 to 23 in 2016, which will provide an increased level of programming for some of our City's most socially vulnerable.

In addition to the regular Green Shack program that operates 5 days per week for 3.5 hours each day, the Pop Up Play program will be available twice a week for 3.5 hours each day in 37 parks.

Neighbourhoods that receive a Pop Up Play program have the option to purchase three additional days of service per week for eight weeks at a cost of \$5000. Please contact your Community Recreation Coordinator (CRC) by March 19, 2016, if you wish to purchase this option.

The list of programs and neighbourhood locations are attached. Neighbourhoods were selected to host summer programs based on the same criteria categories used in 2015.

#### **Community Contribution Request**

In 2015, over 118 community leagues showed their commitment to the program and provided financial support in amounts upwards of \$1000. This allowed the City of Edmonton to provide an additional 28 regular Green Shack programs throughout the city.

We greatly appreciate these contributions and hope that your league will support the Green Shack program this year with a financial contribution. If your league decides to contribute to this popular program, we ask that you pass a motion as a sign of commitment by March 19, 2016, and follow up by providing your contribution cheque, made out to "The City of Edmonton", to your CRC by April 8, 2016.

#### **Funding Opportunities**

Community leagues who are interested in providing their own recreational programming can apply for Student Temporary Employment Program (STEP) funding. More information on this program is available online at AlbertaCanada.com/STEP. The deadline to apply is February 29, 2016. *Note: STEP positions secured by leagues can no longer be administered by the City at the direction of the province.* 

The federal grant program Canada Summer Jobs is also available. Visit the servicecanada.gc.ca website to learn more. The deadline to apply is February 26, 2016.

If your community would like to offer alternative programming, or if you require more information on this summer's programs, please contact your CRC.
